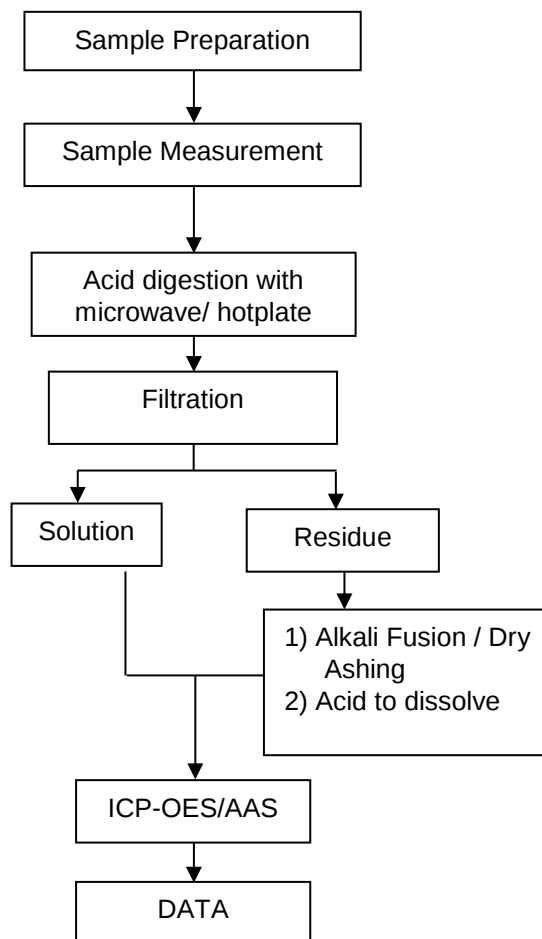

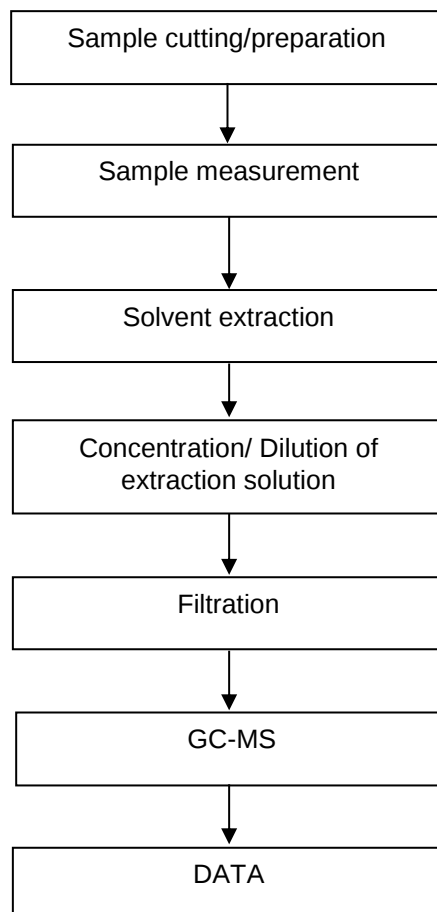

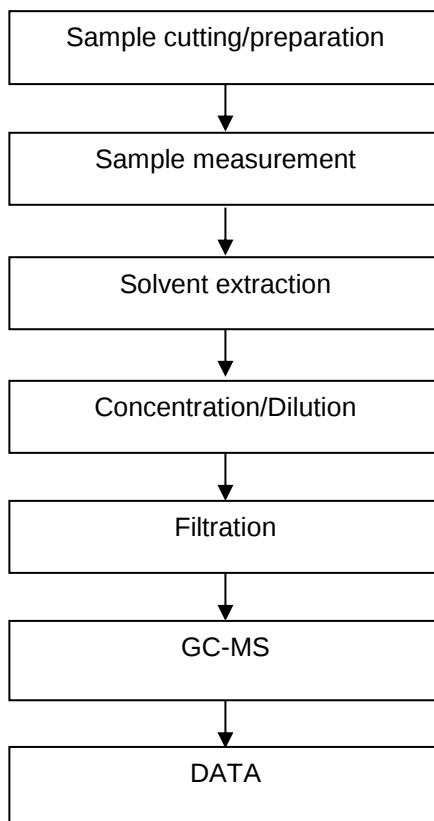

Phthalates Testing Flow Chart



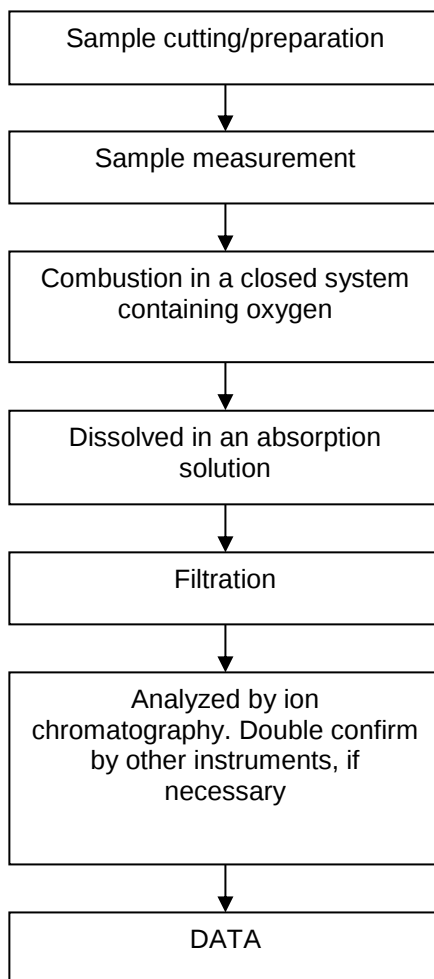

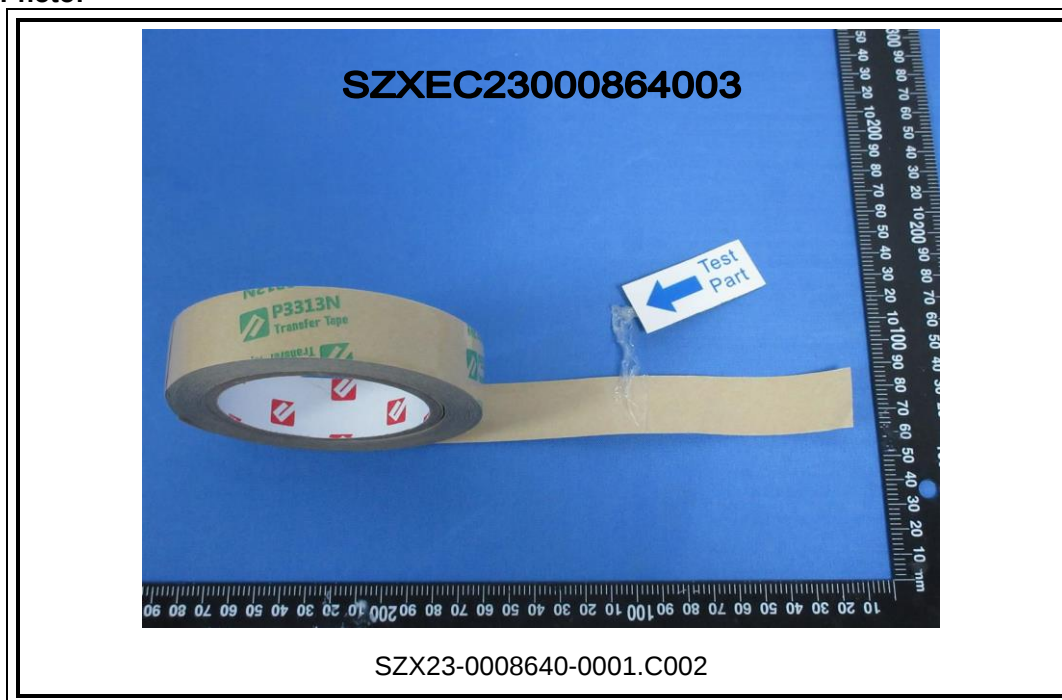
