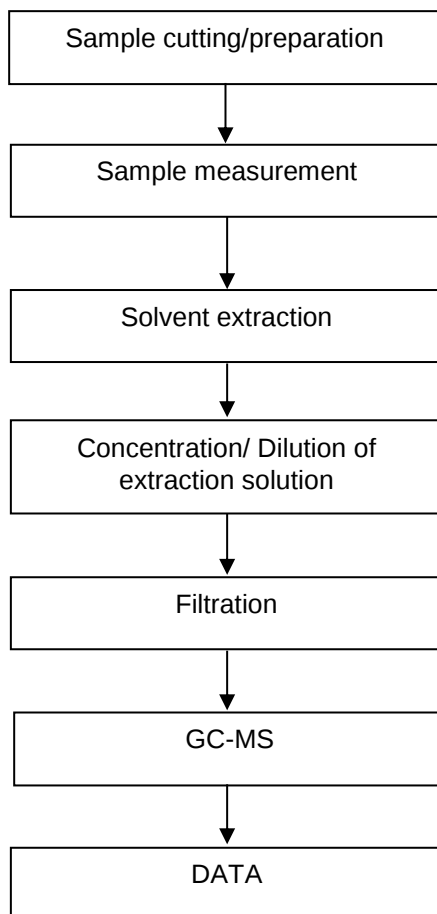

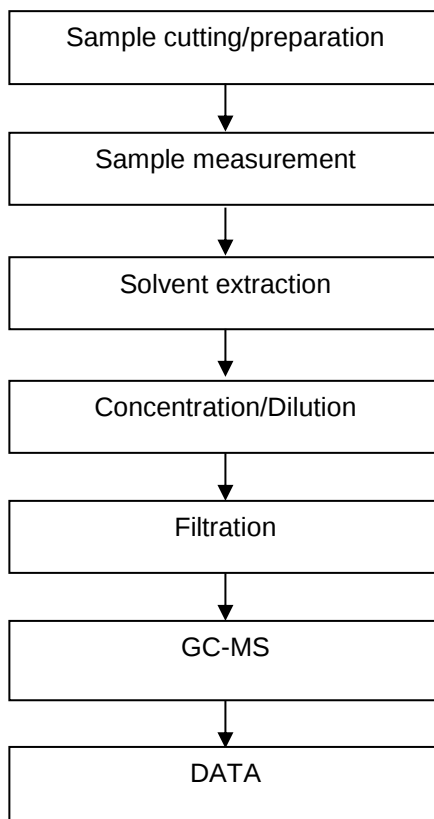

Phthalates Testing Flow Chart



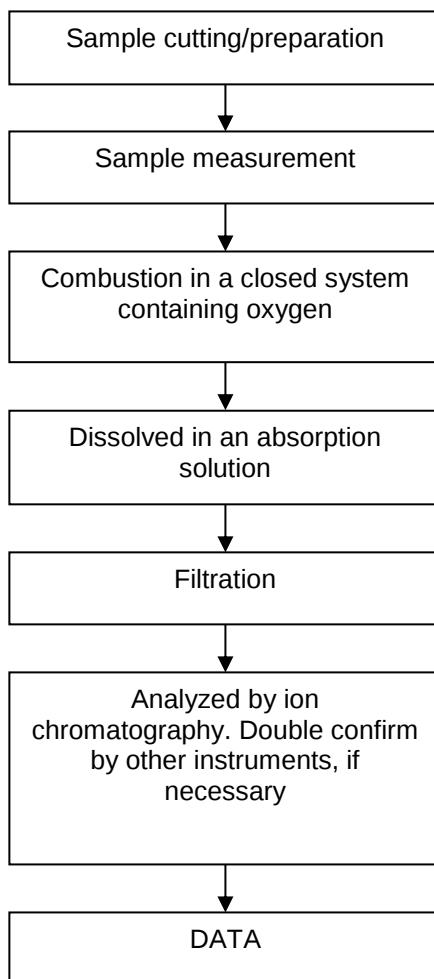

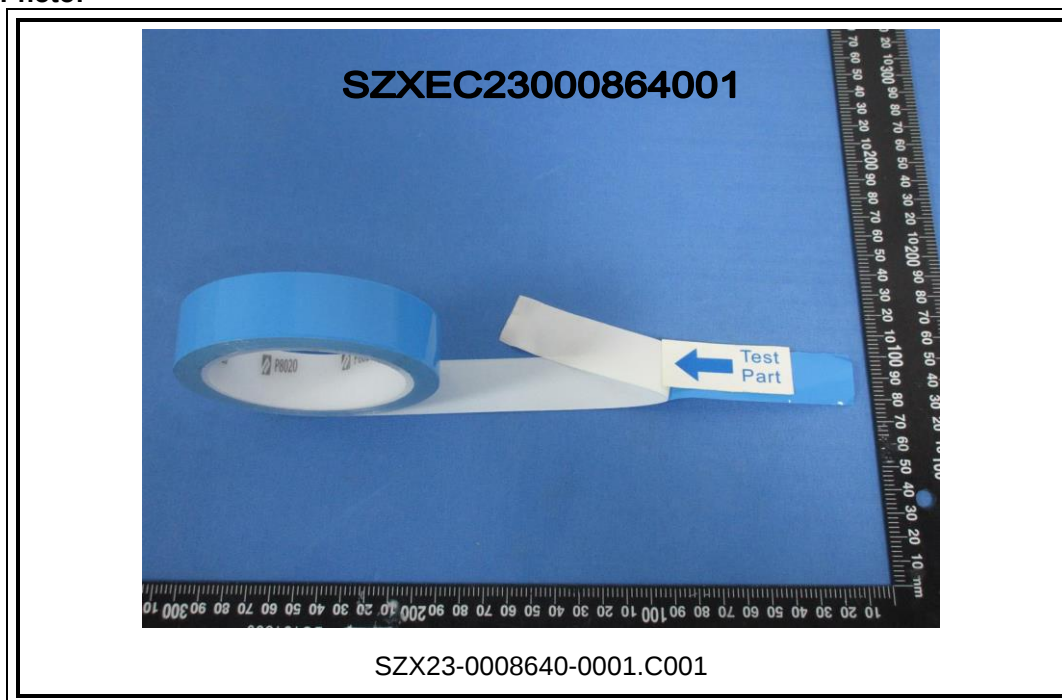
